# Boletín Epidemiológico

- ❖ El Boletín Epidemiológico semanal del Sistema Único de Información, es el medio oficial de difusión de la morbilidad del Sistema Nacional de Vigilancia Epidemiológica (SINAVE).

Este documento responde al inciso 10.1 de la NORMA Oficial Mexicana NOM-017-SSA2-2012, Para la vigilancia epidemiológica, que a la letra dice “La información resultado de la vigilancia epidemiológica debe difundirse a través de reportes impresos o electrónicos que favorezcan la accesibilidad a los datos, de acuerdo con lo establecido en el apéndice informativo C y los manuales correspondientes”. También da cumplimiento al Reglamento Interior de la Secretaría de Salud, el cual establece en el Capítulo X, Artículo 32 Bis, inciso XIII que la Dirección General de Epidemiología debe “Difundir, en forma oportuna los resultados e información generada por las acciones de vigilancia epidemiológica”.

- ❖ Este boletín cumple con la función de difundir los casos nuevos de los padecimientos sujetos a vigilancia cada semana por sexo, grupo de edad por Jurisdicción é Institución.
- ❖ Se publica cada semana y difunde la información de 146 enfermedades sujetas a Vigilancia Epidemiológica.

# Tuberculosis

## ¿Qué es la tuberculosis? (TB)

La tuberculosis es una de las enfermedades infecciosas más antiguas y conocidas de la humanidad. De acuerdo a la Organización Mundial de la Salud (OMS), un tercio de la población mundial está infectada por el Bacilo de la Tuberculosis (*Mycobacterium tuberculosis* o “Bacilo de Koch”), con el riesgo de desarrollar la enfermedad en algún momento de su vida. Se considera un desafío vigente para la salud pública de países como el nuestro ya que una persona enferma por TB sin tratamiento puede infectar de 15 a 20 personas por año.

La TB puede afectar cualquier órgano del cuerpo humano; sin embargo, la forma más frecuente es la que se manifiesta en los pulmones (tuberculosis pulmonar) en un 85% de los casos. Otros lugares frecuentes donde se puede manifestar son: ganglios linfáticos, riñones, cerebro (sistema nervioso central) y huesos.

La presencia y evolución de la enfermedad, así como el pronóstico pueden empeorar si la persona padece diabetes mellitus, VIH-SIDA, alcoholismo, desnutrición, cáncer o situaciones en las que la persona tenga baja inmunidad. Se puede aumentar el contagio si la persona convive con personas enfermas de TB sobre todo en lugares con poca ventilación.

Existen grupos de personas que pueden tener más riesgo de enfermar debido a sus condicionantes sociales, por ejemplo, niños, ancianos, privados de su libertad, personal de salud, migrantes, indígenas e indigentes.

## ¿Dónde se encuentra distribuida la TB?

Más de la mitad de todos los municipios del país, notifican casos de tuberculosis cada año, prácticamente hay TB en todo el territorio mexicano, sin embargo, las entidades federativas de mayor número de nuevos casos y muertes por esta causa son: Baja California, Veracruz, Guerrero, Sonora, Tamaulipas, Chiapas, Nuevo León y Tabasco. La mayor concentración de afectados se encuentra en las grandes ciudades o municipios de mayor número de población (Tijuana, Mexicali, Cd. Juárez, Veracruz, Acapulco, Reynosa, Matamoros, Hermosillo, Tuxtla Gutiérrez, Tapachula, Monterrey y Tabasco entre los principales).

## ¿Cómo se transmite la TB?

La transmisión de la tuberculosis pulmonar (TBP) es por vía aérea cuando un enfermo expulsa micro gotas de saliva con bacilos de la tuberculosis (aerosoles) al toser, hablar, cantar o estornudar cerca de otras personas sanas. Una medida para reducir el riesgo de contagio es que las personas se cubran la boca y la nariz al toser o estornudar.
