





También da cumplimiento al Reglamento Interior de la Secretaría de Salud, el cual establece en el Capítulo X, Artículo 32 Bis, inciso XIII que la Dirección General de Epidemiología debe “Difundir, en forma oportuna los resultados e información generada por las acciones de vigilancia epidemiológica”.

- ❖ Este boletín cumple con la función de difundir los casos nuevos de los padecimientos sujetos a vigilancia cada semana por sexo, grupo de edad por Jurisdicción é Institución.


